Constantinople Ford Assembly Plant

As of general interest in connection with ultimate free port activities of Constantinople, we give below in translation the full text of the agreement recently closed between the Turkish Government and the Ford Motor Company Exports, Inc., a New Jersey corporation. This contract, published in the Turkish Official Journal in Angora on February 14, 1929, law No. 1391, was passed on February 2, 1929.

A further contract for the lease of the Tophaneh warehouses was signed on February 9th, and the evacuation of these buildings is now under way.

Law No. 1391, passed February 2, 1929

ARTICLE 1.— The contract signed at Angora in November 1928 with the American Ford Motor Company Exports, Inc., and the letter attached thereto have been ratified.

ART. 2. This law is effective from the date of its publication.

ART. 3.— The Ministers of Finance and Economy are charged with the enforcement of the provisions of this law.

CONTRACT

BETWEEN

Saradjoglou Shukri Bey, Minister of Finance, acting for the Government of the Republic of Turkey, to be named in the text of the contract as the "Government",

on the one part,

AND

William G. Collins, representing and empowered to act, as per legalized power of attorney, in the name of Ford Motor Company Exports, Inc., incorporated and operating upon the laws of the State of New Jersey of the United States of America, and to be named in the text of the contract as the "Company",

the following has been agreed upon:

THAT:

ARTICLE I.— The Government grants the Company under the conditions clearly set forth below, the right to construct, establish and operate, within the boundaries of the Constantinople Customs, with offices of administration required for this work, an assembly plant for the local preparation, completion and finishing of automobiles, trucks, tractors, airplanes and material and parts and accessories and for the preparation of bodies, from material brought here unassembled and in pieces. Completely finished and assembled automobiles, however, shall not be introduced into this place. Only automobiles which are not subject to the premium are exempted from this stipulation. This contract is valid for a period of 25 years from the date of its signature and exchange by the two contracting parties.

ART. 2.— Said establishment will be created in a place to be agreed upon by the Government and the Company and be named in the text of the contract as a "free place" which will be considered as outside the country; and for the purpose of assuring the functioning thereof all requisite automobiles, trucks, tractors, and spare parts and other tools and implements and materials to be introduced into this place occupied by the Company, as well as transactions in its offices, shall be exempted, during the term of this contract, from customs duty and other import dues of any kind and all other taxes. War material and chemical preparations which involve the public surety and general health, the importation of which is prohibited by law, shall not be supplied and introduced by the Company. The Company is permitted, however, to introduce such chemical and other preparations and materials the use of which is required in the assembly operations.

ART. 3.— The Company is permitted to reexport all goods, materials, tools, machines and other supplies which it may bring in and import according to Article 2, and for which it is exempted from the payment of customs duty and octroi tax and all kinds of dues and imposts. Of these, the payment of customs duty, transaction tax and other dues and imposts usually collected at the time of importation is, however, compulsory on automobiles, trucks, tractors, spare parts, airplanes, etc., which are brought out of the "free place" mentioned above and introduced into the country.

ART. 4.— In order to facilitate the supervision and control duties of the customs administration, the Company undertakes to construct in the free place one or more barracks to serve as lodges for the customs guards and to pay into the treasury a sum to meet the salaries of the employees which will be charged with the control, in proportion with the salaries received from the Government by officials of the same class and rank.

In case, however, the Government establishes at a later date a free port at Constantinople and should the free place to be occupied by the Company come within this free port, the private supervision and control over the Company will be removed and there will be applied to the Company the rules and provisions to which will be subjected the owners of other establishments created within the free port, in which case the Company will be released from the engagements relative to the construction of the barracks and payment of salaries to the employees mentioned in paragraph one of this article.

ART. 5.— No taxes will be collected on any automobiles, trucks, tractors, airplanes, and spare parts, as well as on materials and machines pertaining to the same, ordered by the administration of the Ford Establishment in the free place and forwarded directly from the United States of America to foreign countries, nor will it be liable to any tax whatsoever on automobiles, tractors, airplanes, and spare parts and accessories to be shipped outside of Turkey from the factory in the free place, although they be entered in the registers.

The Company will not be bound to keep in the Turkish language its books and correspondence covering its transactions within the free place and it will be exempt from obligations such as registration and obtention of permit and membership in the Chamber of Commerce.

On goods imported from the free place into the country, however, it will pay the duty and taxes mentioned in Article 3, as it will also be liable to the same taxes and subject to the performance of the same duties and to keep its transactions and correspondence in Turkish as all firms in the country, if it opens an office for their sale within the country.

Although the Company may open a showroom within this free place, it shall not maintain a sales store; it may effect sales only to its agents.

ART. 6.— The Company is obliged to withhold from the salaries and turn over to the Government, according to the law, on clerks and employees, the income and other taxes, for those employed in the assembly plant as well as in the office in the free zone.

ART. 7.— Although the liability to customs duty of machines and material forwarded from the free place and imported into the country for sale has been set down in Article 3, the Government in turn, taking into consideration the advantages which will result for the country's economic life from this establishment and especially the fact that the retouching, painting, assembling and other finishing operations of the automobiles will be executed by local labor, undertakes the payment of a premium of THIRTY Dollars for every one of any kind of automobile, truck, and tractor imported into Turkey. It is a condition, for the Company to become entitled to this premium, that the major part of assembling, painting and retouching shall have been executed and completed in the establishment in the free place.

This premium of THIRTY Dollars which the Government will pay the Company, shall not exceed 20% of the Customs duty the Company will pay to the Government, and in case it exceeds same, it will be reduced to such a proportion.

It is understood that the Government will pay no premium for materials which, in principle, are exempt from import duty.

Finishing operations are understood to be, besides the general assembling itself, processes such as; upholstering connected with seats, floor covering, and sewing, interior furnishing: the setting together of the body parts and iron and/or steel sheets; painting; assembling of the body; the preparation and assembling of the front and rear axles; the operation of soldering by electricity certain sheets of the body and other parts; the enamelling of certain parts of the automobiles and trucks, the decoration of open and/or closed cars, the putting on of the tops of open and closed cars, etc.

While machines of which the general finishing process has been

effected in the free place benefit from this premium of THIRTY Dollars of the Government, and although Phaetons, Tudors, Roadsters and automobiles of models to be adopted, as well as trucks, will become entitled to this premium because their painting and assembling has been entirely effected in the free place, and as bodies for Coupé and Fordor models, made by body factories which are not in the Ford organization, may come complete into the free place in Constantinople, the premium which the Government will pay for the latter will be only FIFTEEN Dollars each, and should any automobile model other than those existent at present be created in the future, of which again only the body in a complete state is introduced into the free place, the premium which will be paid at the importation of such models into the country will also be FIFTEEN Dollars.

It is clearly expressed, however, that of such automobiles the body only will arrive ready-made and that the chassis as well as the other parts will be prepared, assembled and finished in the Constantinople establishment as usual.

The payment to the Company of the premium at the passage of each car through the customs is stipulated, and the Government agrees to draw up regulations in this connection and to communicate same to the Customs Administration.

ART. 8.— The Company shall raise by progressive increases the number of officials and employees of Turkish citizenship which it will employ in its establisment in the free place to a proportion of 60% within a period of two years from the date it starts its activity, and shall have advanced this proportion to 75% at the end of the sixth year.

ART. 9.— In case a forced loan is issued in Turkey, the Company in its free place will be exempt therefrom.

ART. 10.— The Ford Company will conduct its loading and unloading operations by letting the steamers carrying its goods come alongside the shore of the free place, with its own means and Turkish workers, without paying to anyone whomsoever a fee or royalty. It shall not be permitted, however, to perform transport operations within the harbor nor the loading and unloading operations of steamers anchoring off the port, which operations shall be executed by concluding an agreement with the Monopoly Company of the Constantinople Harbor.

In the event of the suppression of said monopoly, it (the Company) will have its loading and unloading operations carried out according to the Cabotage Law No. 815.

ART. 11. - Within the country the Company accepts and undertakes that it will give preference under equal conditions to Turkish merchants and registered Turkish establishments, for the transportation of its merchandise and goods as well as for the purchase of the goods which it will need.

ART. 12.— The Government will visa the passports of the Company's travelling officials for their free entrance into Turkey and their exit, to be valuable for a period of one year, which visa will be successively renewed for one year.

ART. 13.— In case technical reasons do not prevent the use of Turkish coal, the Company agrees to use Turkish coal, under the condition

that the prices are not high if compared to those for coal arriving from other places.

ART. 14.— In case the Government grants, at a later date, more rights and facilities to other automobile establishments and to other persons and companies engaged in similar business within any free zone, the Ford Company also will benefit fully therefrom.

ART. 15.— The Government will not give permission for the establishment of an automobile factory to be engaged in the same operations, within a circumference of at least 400 meters from the free place the Company will occupy.

ART. 16 — All kinds of disagreements which may arise between the Government and the Company as resulting from the interpretation of the provisions of this contract, shall be settled and decided by two arbiters appointed by both parties within 15 days from the date of application of one of the parties.

Should the two arbiters not come to an accord or one of the parties, not designate its arbiter within the fixed term, the matter shall be settled and decided by the First President of the Court of Cassation of Turkey or by an impartial arbiter appointed by him.

The decision given by the two arbiters unanimously or by the third arbiter independently is final and binding.

ART. 17.— The Company shall start repairs and preparations following the delivery to the Ford Company of the Tophaneh warehouses, which shall be caused by the Seiri Sefain Administration to be completely evacuated, and shall perform the activities set down in the contract nine months after the taking over of the building.

In case a prolongation of this delay is rendered necessary by legally-admitted causes, the Government will consent to a required extension after due examination of said causes.

In case said preparations are not completed and activity has not been started within this latter delay, the contract shall be cancelled.

ART. 18.— The Turkish text of this contract is the original; it has been drawn up in two copies and exchanged in Angora, and shall be valid from the date of the signature.

LETTER

To the Ministry of Finance of the Government of the Republic of Turkey.

Sir:

I have the honor to submit for consideration that I have accepted the substitution of the term «outside the customs» for that of «outside the country» mentioned in the second line of Article 2 of the contract concluded between the Government of the Republic of Turkey and ourselves, dated November 27, 1928.

American Enterprise in Turkey

The Work of Fox Brothers International Corporation

We learn that Messrs. Fox Brothers International Corporation, 33 Rector Street, New York, are proceeding at high pressure on the construction of the most modern and up-to-date workshops at Kaiseria, yet designed for Turkey, the contract for which was obtained by Fox Brothers International Corp'n last year. Already work to the value of half million Turkish Pounds has been completed, and an extensive construction program has been elaborated which will commence when weather becomes favorable.

We had the pleasure of an interview with Mr. W. S. Jackson, Director of eastern affairs, who explained to us that the installations at Kaiseria have been designed in such a manner that Kaiseria becomes an entirely independent and self-supporting railway center. The contract obtained by Fox Brothers and upon which they are now working, comprises locomotive and car repair shops, store houses, warehouses, engine sheds, general offices, homes for officials, together with the most modern sanitary and water supply outlay. The shops comprise complete electric power, compressed air, hydraulic and heating installations, and the machinery to be installed for which Fox Brothers are equally contractors, will comprise the most modern tools obtainable today. Apart from the construction of workshops, Fox Brothers have also in hand complete station layout for Kaiseria including a fine up-to-date station building designed in co-operation between the Turkish Government officials and Fox Brothers. The Yard layout at Kaiseria is designed on the extensive scale and with an eye to future developments.

This well studied development scheme on the part of the Turkish Government to turn Kaiseria into a great railway center will have a tremendous economical effect upon the town itself. Kaiseria, at all times an important caravane and commercial trade center of Central Anatolia, now becomes elevated to a position of primordial importance, although the railway has only been in service to Kaiseria for slightly over a year, the economic results observed at Kaiseria are astonishing. This abundently demonstrates the wisdom of the policy of Ismet Pacha in forcing the advancement of railroad construction.

Constantinople Opium Report for February 1929

It was stated in our January report that a very bad weather prevailed during the second fortnight of the month, and that the market closed very firm.

Heavy snow-storms prevailing early in February accentuated the firm tendency of the market. Sales during the first fortnight of the month were therefore not large owing to an increase in prices, as follows:

News coming later from the Interior concerning the crop was contradictory to the pessimist rumors circulated on the market as it proved that only crops of neighboring agricultural districts of Constantinople were injured as a result of the bad weather. As a consequence large sales took place during the second fortnight of February with prices almost the same as those of the first fortnight, as follows:

The market closed very firm.

Prices of opium at Salonica are 15% higher as compared with those of Constantinople, thus making stockholders more difficult towards the end of the month.

Total arrivals at Constantinople since the opening of the season to February 28th amounted to 2,007 cases as against 1,991 cases during the corresponding period of last year.

New Crop. — From the above it is noticeable that owing to the bad weather prevailing throughout almost the whole month, certain damages must have been caused to the crop, especially in districts where it did not snow but where the cold was very severe, but as yet the extent of these damages cannot be ascertained. On the other hand it should not be forgotten that even at normal times the crop never reaches the volume of sowings.

TURKEY

Temporary Reduction of Import Duty on Flour. — The press of February 19 carried the announcement of the passage by the National Assembly of a bill providing for a temporary reduction of the duty levied on flour imported into Turkey. The following is a translation of the law as given in the Aksham:

"ARTICLE 1.— The initial tax on flour as specified in the first paragraph of Section 53 of the Customs Tariff of March 10, 1332 is lowered until the end of August, 1929, to 46 piasters.

"The Council of Ministers is authorized to raise it to 60 piasters after that date.

"ART. 2.— By decision of the Council of Ministers, law No. 1005 of April 1, 1927 concerning flour imported from countries with which a commercial treaty or modus vivendi has been concluded may be set aside.

"ART. 3.— This law will enter into effect at the time of its publication and will be valid until November 15, 1929."

Irrigation Plans.— According to the Angora correspondent of the Aksham a commission appointed by the Ministry of Public Works is drawing up plans of extensive irrigation works which will be carried out over a period of 19 years and involve an expenditure of 250,000,000 liras.

GREECE

Foreign Trade of Greece in 1928.— The statistical Department of the Ministry of National Economy has published Statistics on the foreign trade of Greece in 1928. According to these figures Greece imported 2,359,156 tons of goods in 1928 of a value of 12,488,122 thousand drachmas as against 2,275,213 tons in 1927 of a value of 12,601,948 thousand drachmas. Exports amounted to 645,493 tons in 1928 of a value of 6,282,075 thousand drachmas as against 632,461 tons in 1927 of a value of 6,037,411 drachmas. Thus imports exceeded exports in 1928 by 6,206,047 thousand drachmas as against 6,564,537 thousand drachmas in 1927.

The United States rank first in imports with a proportion of 16%. Then follow Great Britain with 14%, Germany with 9%. In exports Germany ranks first with a proportion of 25%, the United States rank second with 20%, Italy third with 17% and Great Britain fourth with 13%.

Agricultural, horticultural and animal products rank first in imports with a proportion of 36%. Then follow yarns and textiles with 16%, minerals with 11%, metals and products with 11%. In exports agricultural and horticultural products rank first with a proportion of 72% (principally tobacco with a proportion of 51% and raisins with 15%). Then follow alcoholic drinks with 8% (especially wine), oil and metals with 4%.

BULGARIA

Bulgarian Public Finances in 1928. For the first time the Bulgarian budget balanced and even showed a surplus of 228 million leva during the fiscal year 1927-1928. It is hoped that the efforts of the State to close the 1928-1929 budget without a deficit will be crowned with success. The practice of the monthly budgets instituted by the Ministry of Finance, whose aim is to balance receipts and disbursements every month, gives satisfactory results. On the other hand, an increase in receipts during the present budget is established. Total receipts for the first nine months of the fiscal year 1928-1929 amount to 5,711 million leva as against 5,303 for the corresponding period of the fiscal year 1927-1928, an increase of 408 million leva. Receipts for the first nine months of the fiscal years 1927-1928 and 1928-1929 were as follows:

Bulgarian Railway Traffic. — Bulgarian railway traffic during the month of January amounted to 16,938 carloads of goods. Railway traffic in December was of 25,553 carloads of goods, or an increase of 8,615 wagons.

1928 Tobacco Market.— The tobacco market during 1928 was very active. As in 1927 the first campaign in 1928 was opened in September when the harvest had not been yet finished.

The 1928 crop was rather weak as regards quantity owing to the prolonged drought, estimated at approximately 18 million kilos. As regards quality the crop was very good and compared with that of 1923.

RUMANIA

Turkish-Rumanian Commercial Treaty.— The Ministry of Finance has addressed a circular to the custom-house bureaus advising them that in virtue of a communication from the Ministry of Foreign Affairs the actual commercial treaty has been extended for another six months, that is up to August 11, 1929.

Direct Telephone Service Bucharest-Budapest. - On February 14, a direct telephone service was inaugurated linking Bucharest to the capital of Hungary. The first conversation took place between Mr. Marinesco, director general of the Rumanian P.T.T. and Baron Gabriel de Szallay, director of the Hungarian post offices. It is stated that beginning February 18, this telephone line will be opened for public use in Bucharest and ten days later, the people from Timishoara, Arad, Oradia Mare and Cluj will also be able to talk with Budapest. The tax per conversation from Bucharest will be 3 gold francs.

State Receipts and Disbursements during January 1929 .-Receipts of the State of Rumania in January for the year 1929 were 1,763,-811,041 lei, and expenditures 859,239,183, an excess of 904,571,858 lei. Receipts in January 1929 for 1928 were 578,909,049 lei and expenditures 1,309,302,607, a deficit of 730,203,612 lei.

PALESTINE

Trade Returns.— Figures available for trade during the first ten months of 1928 show a large increase in imports and a marked reduction in exports, as compared with the corresponding period of last year. While definite conclusions cannot yet be drawn until the returns for the whole year are published it can be stated that in several respects the position is not as unsatisfactory as would appear from the bare figures.

Imports during January-October amounted to LP.5,486,192, being an increase of LP. 472,683 or 9%. While this increase was caused in part by a rise in imports of foodstuffs, due to the poor harvest, it was also a consequence of a renewal of building operations and a certain revival of development activities generally.

Thus considerable increases are shown in imports of timber (a jump of over LP.71,000), bars and angles (over LP 3,000), tubes and fittings(LP.23,000) machinery, etc.

A remarkable rise is shown in imports of automobiles and motor fuel, testifying to the great development in motor transport. Imports of benzine increased by LP.48,000 and automobiles by LP. 64,000. On the other hand, increases are also shown in imports of certain raw materials, viz: copraunrefined olive oil, and so forth.

As regards exports, the figures are LP.1,244,588 for the ten-month period, as against LP.1,575,223 last year. The reduction is primarily due, as stated above, to the poor agricultural results of the past year. Orange exports decreased from LP. 655,425 in 1927 to LP. 501,957; wheat exports dropped from LP.37,420 to LP. 14,868; barley exports from LP. 72,157 to LP.49,081; water melon exports show the considerable decrease of LP.63,761.

At the same time it is gratifying to note that in industrial exports progress has continued. Increases are recorded in exports of almost all manufactured goods, with the exception of olive oil and native soap, due chiefly to the poor olive harvest, and cigarettes, caused by the loss of the industry's only export market of any importance—Transjordan—where branch factories have recently been established by Palestinian firms.

The most notable rises are shown in exports of cement, hosiery, toilet soap and sesame oil. The value of cement exports rose from LP.19,245 to LP.28,061 an increase of 42%; that of hosiery from LP.8,164 to LP.13,714—a rise of 55%; that of toilet soap from LP.578 to LP.2,094; that of sesame oil from LP.1,440 to LP.11,305. A similar increase is shown in exports of artificial teeth (from LP.611 to LP.2,935).

Finally, it should be noted that the wire industry, which for a long time had to complain of a falling off in trade, shows a satisfactory export record this year, goods to the value of LP.28,604 being sold abroad as against LP.18,460 last year.

World Motor Census

The American Automobile (Overseas Edition) for March gives its annual January 1, 1929, census of motor vehicles throughout the world, the figures shown being secured each year from the most reliable sources obtainable, both official and trade.

Excluding motor cycles, the grand total is 31,929,952, of which 26,785,419 are motor cars. The total increase during the year was 2,291,417 which represents an increase of 8.6 % over Jan. 1, 1928. Outside of the United States the increase was more rapid, being 16.5 %.

The total of motor cars for 1927 was 11,087 and that of trucks 3705, as compared with 18,196 and 7,125, respectively, in 1928. This means an increase

of 64 % in the number of motor cars shipped, and of 92 % for trucks.

Shipments to Italy, Egypt, Greece and Turkey are partially in transit to other destinations, while in turn these countries also receive goods through other transit through other transit ports.
